3. Review of Status Report on AQAR 2020-21

The Coordinator, IQAC, PIMS-DU explained methodology/ process of submission of AQAR for last 4 years to NAAC, as under:

- The AQAR for the academic Year 2016-2017 and 2017-18 were prepared & submitted as per the format given by NAAC in the word file format "through email to NAAC.
- The AQAR for the Academic Year 2018-19 & 2019-20 were prepared and submitted as per online format to NAAC portal by using login ID and password.
- However, NAAC has designed/launched a new online format on the basis of Health Sciences Institutions Manual for Self-Study Report which is applicable from the academic year 2020-21.The new format of AQAR is like a mini SSR format & stands very helpful in preparing 5 years Self Study Report(SSR) for NAAC Cycle 3rd.

As per decision taken in the meeting chaired by Vice Chancellor on 14.7.2021, IQAC, PIMS-DU the circular was issued to all HOIs for seeking inputs/ data for the AQAR 2020-21 preparation in accordance with letter **Ref. No/PIMSDU/ R/IQAC/ AQAR / 2021/1185 dated 14/07/2021** and submit data/information/ inputs for AQAR 2020-21 on or **before 28/7/2021**.but it was not happened as per time given to all Institute. Hence, The Vice Chancellor appealed to all Institutional IQAC Coordinators to put up status report on AQAR 2020-21 preparation of their institutes respectively.

All 6 Institutional IQAC Coordinators presented status report one by one with some issues/ problems /difficulties encountered and requested the University for Extension in time to submit report to the University IQAC Cell.

Institutional IQAC Coordinators told that they are facing common problems like definition of Academic Year for the purpose of collecting data pertaining to Research Publications, definition of Financial Year for the purpose of collecting data on the Project Grants and physical infrastructures and the definition of Academic Calendar for the purpose of collecting data on Exam. Results and Academic Activities

It was resolved decided that to consider Finances & Project Grants under Financial Year i.e. April to March and Publication data be considered under calendar year i.e. January to December and remaining data/information be considered under Academic Year. It was decided further that to prepare the AQAR for academic year 2020-21 with all documents /evidences along with Geotagged Photographs.

It was resolved that all 6 Institutes allowed to submit full and final AQAR Report for the academic year 2020-21 on or before **15th October**, **2021** to University IQAC Office, PIMS-DU. It was also resolved that IQAC, PIMS-DU should compile the reports and finalize the AQAR report of the University by first week of Nov. 2021.


