#### Preface and Introduction of Pravara Institute of Medical Sciences-DU

#### **The Beginning** :

**Pravara Medical Trust** was established in 1972 by the rare visionary, most revered and respected, Dr. Vitthalrao Vikhe Patil (Padmashri Awardee), the founder of first co-operative sugar factory in Asia, in 1948, at Loni – a remote village of Maharashtra, a feat appreciated by **Pandit Jawaharlal Nehru**, the then Prime Minister of India. He also initiated and led Pravara cooperative movement for inclusive-holistic rural development, education and health care. The functional and realistic model of integrated, participative, sustainable rural development as well as comprehensive holistic health care and education, successfully launched by the rare visionary and ambassador of socioeconomic change, is popularly known as *"Pravara-Loni Model of PURA"*, commended by **Dr. APJ Abdul Kalam**, the then President of India.

#### The Background :

**Dr. Vitthalrao Vikhe Patil**, a farmer of Loni, a draught prone backward village of Maharashtra, realized the importance of integrated rural development to solve the problems of illiteracy, poverty, hunger, unemployment, social inequality, economic exploitation, poor public and personnel health, shelter, clothing and basic amenities in rural areas, which were the real challenges before a young independent India in 1947. The rare visionary was with full of ideas, courage and determination to address these issues head on directly. He initiated the revolutionary cooperative movement of farmers to achieve the impossible – "Integrated holistic sustainable rural development". He aimed at realizing "Gram Swaraj" in true letter and spirit. The cooperative movement of farmers led by him, aimed at the issues of agriculture, livestock development and agrobased industry (1948), primary, secondary and collegiate education (1964) and cooperative banking (1972). All these initiatives started transforming the draught prone backward village towards the path of integrated sustainable rural development – social, political, economical. This realistic cooperative model was appreciated by one and all, across the nation.

In order to address the issues of comprehensive rural health care, he established the **Pravara Medical Trust in 1972, Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital, in 1976** at Loni and several rural health centers.

For this illustrious social work and sacrifice, Government of India honored him with the award of **"Padmashri"** in 1962. Pune University conferred on him the honorary **D.Lit** in 1978 and established a Chair in his name to undertake Research in Rural Development (1981). Mahatma Phule Krishi Vidyapeeth conferred on him the honorary **D.Sc.** in 1979.

Film Division of India presented a documentary film on his achievements entitled "Shoulder to Shoulder" in 1953. Veteran Girish Karnad directed a documentary "Sweet Revolution" in 1986, based on his accomplishments. Shri Rajamangal Vedekar and Shri. Shivajirao Sawant has written biographic books (1977/1985) on the life and mission of this illustrious leader. We offer our tributes to this cellular visionary.

#### **Development, Consolidation and Expansion of Co-operative Movement:**

The mission and ideas of this great visionary were further developed and nurtured by his son **Dr. Balasaheb Vikhe Patil**, Padmabhushan Awardee, Parliamentarian (8 times), Statesman, humble social worker and visionary leader of masses. He continued the cooperative movement for integrated rural development and further strengthened comprehensive rural health care and established Health professional Colleges in Loni.

To meet the national requirement for qualified health professionals, PMT established the various teaching institutes:

- 1. Dr. Balasaheb Vikhe Patil Rural Medical College (Formerly Called as a Rural Medical College) (1984)
- 2. Rural Dental College (1989)
- 3. Dr. APJ Abdul Kalam College of Physiotherapy (1997)
- 4. Smt. Sindhutai Eknathrao Vikhe Patil College of Nursing (Formerly Called as a College of Nursing) (1998)
- 5. School of Public Health and Social Medicine (Formerly Called as a Center for Social Medicine) (2001)
- 6. Centre for Biotechnology (2000)
- 7. College of Pharmaceutical Sciences (2022)

These constituent colleges have the approval and recognition of respective statutory councils (NMC, DCI, INC, MSOTPT, UGC).

#### **Genesis of the University: PIMS-DU**

In order to achieve the integrated holistic approach in health care, education and research, Pravara Medical Trust (PMT) took positive steps towards the establishment of a deemed university (with the approval of UGC, MHRD, GOI) by bringing all of its colleges and units of health education and tertiary medical hospital under one ambit/ umbrella, in 2003. Thus, the **Deemed to be University** was born at Loni-"**Pravara Institute of Medical Sciences (PIMS-DU)**", a unique feature in Indian professional education system in a rural India. The governance, leadership and management of PIMS-DU are as per regulations governing deemed to be universities, notified by the UGC from time to time (UGC institution deemed to be universities regulations 2010/ 2016/ 2019).

Befitting to the vision and mission of the parent trust, PIMS-DU is imparting quality professional health education at global level and tertiary speciality health care at Loni as well as at doorsteps of 234+ villages spread over 13 talukas and 3 districts with a catchment area of lakhs of people of Maharashtra State. Our rural health care, extension and community health outreach activities have received national and international appreciation and recognition.

#### **Growth and Development of PIMS-DU :**

PIMS-DU is raised up as on a spacious and green unitary campus on 115 acres at Loni, developed as per the master plan and land scaping, housing all the 7 constituent units and their hospitals. It has state of the art building blocks for academic and co-academic programmes, multispecialty tertiary medical and dental hospitals as well as residential facility for students and staff on the campus, all within a walkable distance. It is a near cent percent residential campus provided with all the basic amenities and facilities round the clock, ensuring a home away from the home. It is providing a good multispecialty hospital for enriching clinical resource and care, central library, IT facilities, safety, security, discipline and basic amenities 24x7(water, electricity, maintenance) in a rural area, a real practice of "PURA". It has recruited qualified and experienced staff as per norms of statutory bodies. We have encouraged research through funds, facilities, and incentives resulting in 2000+ publications and collaborative research projects and clinical trials. PIMS-DU publishes its own ISSN peer reviewed medical journal entitled "Pravara Medical Review" indexed in Scopus and UGC list of journals. We have collaboration with 35+ international institutions and industries as well as national institutions. Teachers and students have visited foreign universities on scholarship/ fellowship through Lineus Palme Exchange Accord and Erasmus+ scheme (we are the only the deemed university from India included in this scheme).

PIMS-DU has attracted 200+ students and 50+faculty from foreign universities for research and training. Centre for Social Medicine acts as Mother NGO and a liasoning body for government and semi government organizations and national health schemes. PIMS-DU has a sound financial management and governance system with accountability, transparency and integrity. Annual convocations are held regularly since 2007. So far 15 convocations have been organized. We are proud for having contributed

qualified and competent, health professional, human resource to the national development (Medical doctors, Medical specialists, Dentists, Dental specialists, Nurses, Nursing specialists, Physiotherapists, Specialists in physiotherapy, Biotechnologists, Public health specialists, Ph.D. holders, a total of 5164 graduates and postgraduates). Our students are enriched with good clinical and community health knowledge, skills and competence. We are proud of our **"Pravarites"** serving in India and abroad.

With the benign blessings of **Dr. Vitthalrao Vikhe Patil (Padmashri Awardee) and Dr. Balasaheb Vikhe Patil (Padmabhushan Awardee) Founder, President and Managing Trustee, PMT** and under the guidance and leadership of *Hon'ble Dr. Rajendra Vikhe Patil, Chancellor, PIMS-DU,* we are marching towards our goal – to create "A Healthy Society".

PIMS-DU has grown over the years since its establishment in 2003 and recorded developmental milestones. It strives for global excellence. We believe in expansion, consolidation as well to grow and develop ahead to achieve global excellence, as per global and national expectations, trends and challenges.

We believe in quality movement in all our endeavors. Hence we subject ourselves for continuous regulation and monitoring by statutory bodies – NMC, DCI, INC, MNC, IAP, MSOTPT, PCI and UGC. #### **Introduction :**

The Dr. Balasaheb Vikhe Patil Rural Medical College, since its inception in 1984 - first of its kind in rural India is dedicated to serve society as a center of excellence with emphasis on socially meaningful medical education, research and health care.

It was the culmination of determined efforts of Dr. Balasaheb Vikhe Patil (Padmabhushan Awardee). The idea was to provide an opportunity to the meritorious candidates to become



quality and need based health care providers in their own environment, providing improved accessibility of tertiary and critical care to the rural poor.

Dr. Balasaheb Vikhe Patil Rural Medical College, Located on 140 acres of land, lush green campus with state of art 1275 bedded multi-specialty hospital, is the first of its kind in Rural India. The intake capacity of the MBBS discipline from 125 to 200 in the year 2016-17& MD/MS is enhanced from 93 to105 seats in the year 2021-2022.

## New Teaching & Training Modalities Added and Innovations in Teaching :

The new curriculum of "Competency Based Medical Education (CBME)" as directed by MCI has been successfully implemented from the MBBS batch which entered in our Dr. Balasaheb Vikhe Patil Rural Medical College, Loni in August 2019. Complete syllabus of the first professional subjects as contained in the new CBME, has

been displayed on our website and is being religiously followed.

A one month long "Foundation Course", the first one of its kind to be held for MBBS students and as directed by the MCI/NMC was implemented in August, 2019.

Department of Forensic Medicine and Toxicology started organizing "Moot Court" which has turned out to be a highly appreciated innovation in medical teaching. Also medico-legal autopsies are routinely conducted and demonstrated to undergraduate and postgraduates.

**RURAL DENTAL COLLEGE, LONI** 

**Introduction:** Rural Dental College (RDC), Loni has come a long way from its inception in the form of a few chaired clinic to a multicentric and multispeciality Dental Institute. The institute believes in providing quality dental education to the students to make them globally competitive and highly skilled professionals. Dental health services are delivered to rural and tribal areas which are appreciated worldwide. The institute caters to an array of dental treatment services for more than 1.2 million populations around Loni, making it one of the premiere dental educational hubs in the beautiful state of Maharashtra.



Keeping healthcare as priority for poor and needy people, Pravara Medical Trust established Rural Dental College and Hospital at Loni near holy land of Sai baba's Shirdi in 1989, with a vision of **"Service to Rural people"** by the late Legend Dr. Vitthalrao Vikhe Patil (Padmashree Awardee) and foundation of Rural dental college, which was laid by Dr. Balasaheb Vikhe Patil (Padmabhusan Awardee). Intake capacity of 60 undergraduate admissions per year was increased to 100 undergraduate (UG) seats per year in 2007. Rural Dental College was initially affiliated to the University of Pune and Maharashtra University of Health Sciences, Nashik till it became a constituent unit of Pravara Institute of Medical Sciences.

Today our infrastructure is equipped with modern dental chairs and state of the art laboratories with an intake of 100 undergraduate (UG) students and 22 postgraduate (PG) students and research scholars for PhD program per year. Additionally, UG & PG students are benefitted with training in field of



Oral Implantology, Regenerative Dentistry and preclinical training in skill development laboratory.

The BDS and MDS courses of the College are recognized by Dental Council of India (DCI). Postgraduate (PG) courses are offered in the specialties of (i) Oral Medicine & Radiology, (ii) Prosthodontics and Crown & Bridge, (iii) Periodontology, (iv) Conservative Dentistry and Endodontics, (v) Orthodontics & Dentofacial Orthopedics, (vi) Oral & Maxillofacial Surgery (vii) Pedodontics & Preventive Dentistry & (viii) Oral Pathology and Microbiology. Doctorate of Philosophy (PhD) program in Dentistry is offered since 2012 in all nine specialties.

College has a teaching hospital with all specialties of dental surgery which provides routine and specialized diagnostic procedures including Cone Beam Computed Tomography (CBCT), Digital Orthopantomogram (OPG) and Cephalogram. Treatment procedures like Maxillofacial and Orthognathic surgery, Advanced Conservative & endodontic treatments, Aesthetic dentistry, Ceramics, Cast metal base dentures and maxillofacial prosthesis. Rural Dental College also provides extension OPD services to nearby villages which are attended by UG, PG students & Interns under the supervision of senior faculty. Our teachers aim at meaningful and purposeful goals and objectives, excellence in teaching, learning, research and extension activities. The students of this dental college are benefited with both high technological dental education and simultaneous exposure to the oral health care of rural population through community base training. Extensive preclinical and clinical training is imparted to the students at Rural Dental College & Hospital as well as at its well-equipped peripheral clinical wings.



### DR. VITTHALRAO VIKHE PATIL PRAVARA RURAL HOSPITAL, LONI



Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital, and Medical Research Centre is 1275 bedded Multidisciplinary, Super speciality Hospital with the state-of-art gadgets, equipment's including 64 Rows 128 Slice CT Scan 3 Tesla dedicated MRI, 6MV Photon Linear Accelerator with IMRT & 3 DCRT well-equipped ICUs and ICCU. Besides Modern Hi-tech e-NABL Accredited Central Clinical Laboratory (CCL), hospital houses Blood Bank with component separation facilities. Cancer Treatment & Research Centre is an important part of the hospital. A new Coronary Care unit has been functioning since past Four year more than 2129 angiography and 1078 angioplasty operations have been performed successfully. Ancillary units such as Physiotherapy & Rehabilitation with Holistic Medicine departments for patient care are also available in the hospital.

Department of Radiation Oncology is equipped with a 6 MV medical Linear Accelerator (LA) unit for external radiotherapy treatment (Varian – Clinac – DBX 6 MV with EPID) having 3-Dimensional Conformal Radiotherapy (3D-CRT) and Intensity Modulated Radiotherapy (IMRT) facility from May 2012. Brachytherapy facility is by GammaMediX Plus HDR / PDR remote after loader unit since 2010. Oncology department of Pravara Institute of Medical Sciences (DU) is registered in cancer registry program as a government project "Hospital Based Cancer Registries Data Management Software", from NCDIR, ICMR, Bengaluru (Centre code 513).

In view to cater to the Covid Pandemic, 100 bedded Covid Isolation Hospital with ICU facilities, has been established by Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital.



The hospital provides sophisticated diagnostic facilities like Ultra-sonography, Color Doppler, CT Scan, MRI, DSA, Mammography, Digital X-Ray with PACS, Congenital Anomaly Scan etc. at a reasonable rate to cater for poor patients.

Spacious specialty Out-patient departments and In-patient wards are available with residential expert medical and paramedical teams. NABL Accredited Central Clinical Laboratory



(CCL) consists of Pathology (Morbid Anatomy, Cytology, Haematology), Biochemistry and Microbiology, is well equipped and caters to the needs of patients. The hospital CCL also functions as a referral centre for nearby pathologists and laboratories. In view of the recent Covid Pandemic, NABL Accredited Molecular Biology lab has been established with RT PCR testing facilities.

The Blood Bank of the Hospital is equipped with state-of-art equipments to perform routine and special investigations including HIV Test (Elisa reader) and separation of blood to prepare blood

components. The blood component therapy has proved to be a boon for the needy patients. Dialysis Unit caters to the needs of high incidence of renal failure cases of CKD, insecticide poisoning and snake-bites etc., which is very common among agricultural workers.

Emergency and Trauma care is provided round the clock by experts. These services are augmented with the latest diagnostic facilities like invasive and non-invasive imaging techniques, on the spot transfusion and other resuscitative techniques.

Major as well as specialized surgeries including Pediatric. Neurosurgical Oncology, Urology, Laparoscopic, Spinal, Micro Larvngeal, Ioint Replacement, Oral and Maxillo Facial Surgery, Reconstructive and reconstruction surgeries are performed in a Centrally Air Conditioned Modular Operation Theatre Complex which are equipped with excellent operating and monitoring facilities. The department of Ophthalmology has facilities of Corneal Transplant and Eye bank



Advanced Neonatal Unit, Neonatal Intensive Care Unit and Pediatric Intensive Care Unit takes care of preterm babies, critically ill neonates, infants and children ensuring an excellent salvage rate. Intensive Care Unit is well equipped with state-of-art monitoring and life support systems for the care of the critically ill.

CCU & ICCU is equipped with latest Ventilators, Multipara Monitors, External Cardiac Pace Maker and 24 hours continuous Holter ECG monitoring facilities, caters for the needs of critically ill

cardiac patients.

A well-equipped Medical ICU's, Surgical ICU's and Respiratory ICU's caters for critically ill patients from these disciplines. Medical and surgical ICU also caters for facility of beside Haemodialysis.

**Intervention Radiology :** Dept. of Radiodiagnosis and imaging provides facilities for all vascular and non-vascular radiological interventions.

**Oxygen Supply :** The hospital has a modern MGPS system with tertiary level back up provision in which we have a 650 LPS PSA (Pressure Swing Adsorption) type medical oxygen generator plant as a primary, 10 KL LMO (Liquid Medical Oxygen) as a secondary and 14X2 jumbo Oxygen cylinder manifold as a tertiary source. All these three sources operate through fully automatic cascading panel. In addition to this, each source has a manual by pass provision, in case of any emergency condition of automatic panel failure.



#### **A. Definitions**

- a. 'PIMS-University' means Pravara Institute of Medical Sciences, Deemed to be University.
- b. **'DGHS'** means Directorate General of Health Services, Ministry of Health & Family welfare Govt. of India.
- c. **'Competent Authority'** means the authority appointed by the PIMS University for the purpose of admission process.
- d. **'Application Form'** means prescribed form to be filled by the candidate for applying to admission in MBBS/ BDS courses in PIMS University.
- e. **'Internship'** means the compulsory rotating internship to be completed as per rules of MCI/ NMC/ DCI.
- f. 'BDS' means "Bachelor of Dental Surgery"
- g. 'MBBS' means "Bachelor of Medicine and Bachelor of Surgery"
- h. 'DCI' means the "Dental Council of India"
- i. 'MCI' means the "Medical Council of India".
- j. **'NMC"** means the "National Medical Commission"
- k. 'NEET (UG) 2023' means National Eligibility Cum Entrance Test

#### **B.** Competent Authority

The Competent Authority and also the Co-ordinator of Admission Committee. Competent Authority will supervise and control the Admission process by implementing the admission procedures through Designated Authority.

#### **C. Designated Authority**

The Designated Authority will be responsible to carry out the instructions given by the Competent Authority in respect of admission process (after selected by DGHS) at PIMS-DU for undergraduate courses.

Co-ordinator, PIMS University will be the Designated Authority.

#### **1. Admission Process**

As per the directives of Hon'ble Supreme Court of India and the Ordinances promulgated by the Central Government. Admission to undergraduate courses in Medical (MBBS) and Dental (BDS) for academic year 2023-24 in constituent colleges of Pravara Institute of Medical Sciences (Deemed to be University) will be done on the basis of marks obtained in the NEET (UG) 2023.

Admission process will be carried out by Medical Counseling Committee of DGHS (Directorate General of Health Services, Govt. of India) Ministry of Health & Family Welfare for academic year 2023-24.

#### 2. Intake Capacity and Duration of Courses :

The intake capacity and duration of courses as approved by the respective councils is given below :

#### 3. Distribution of Seats

**a. All India Merit Category (Management/ Paid Seats) :** 85 % Seats are reserved under this category. Admission to this category will be made on the basis of NEET (UG) 2023 Merit list.

#### b. NRI (Non Resident Indians) / PIO (Persons of Indian Origin) / FN (Foreign Nationals) Category :

15 % seats are reserved under this Category.

The Foreign National (FN), wards of Persons of Indian Origin (PIO) settled abroad and wards of Non Resident Indians (NRI) are eligible to apply under this category.

Candidates who fall under the category of NRI as per the directions/ orders of Hon'ble Supreme Court of India in the case (W.P. (C) No. 689/2017-Consortium of Deemed Universities in Karnataka (CODEUNIK) & Anr. Vs. Union of India & Ors.) Dated 22-08-2017 are eligible for NRI Category.

#### 4. Eligibility and Qualifications

- Candidate must be an Indian National. The Nationality Certificate issued by the District Magistrate/ Additional District Magistrate/ Chief Metropolitan Magistrate or a valid passport will be considered as a proof of Nationality.
- The candidate must complete 17 years of age on the **31<sup>st</sup> December**, **2023**.
- The candidates must passed 10+2 (or equivalent) with subject of Physics, Chemistry, Biology/ Biotechnology and English.
- Common Counseling without prejudice to anything stated in the present regulations other NMC Regulations, there shall be common counselling for admission to graduate courses in medicine for all Medical Institutions in India based on the Merit List of the NEET-UG.
- Upper age limit: As per Letter No. U-11022/2/2023-UGMEB, dated 09 March 2023 received from National Medical Commission (NMC), Under Graduate Medical Education Board (UGMEB) regarding the upper age limit, that there should be no upper age limit as decided in the fourth NMC meeting held on 21 October 2021.
- Candidate must have passed any of the qualifying examinations as enumerated below. The Higher/ Senior Secondary Examination or the Indian School Certificate Examination which is equivalent to (10+2) Higher/Senior Secondary Examination which is conducted after a period of 12 years study, the last two years of such study comprising of Physics, Chemistry, Biology/ Bio-technology (which shall include practical tests in these subjects) and Mathematics or any other elective subject with English as a core course.
- **NOTE:** where the course content is not as prescribed for 10 +2 education structure of the National Committee, the candidates will have to undergo a period of one year pre professional training before admission to the Medical Colleges.

#### OR

• The Intermediate/Pre-degree Examination in Science of an Indian University/ Board or other recognized examining body with Physics, Chemistry, Biology / Bio-technology (which shall include practical test in these subjects) and also English as compulsory subject.

#### OR

• The Pre-professional/ Pre-medical Examination with Physics, Chemistry, Biology/ Biotechnology & English after passing either the Higher Secondary Examination or Pre-University or an equivalent examination. The Pre-professional/Pre-medical examination shall include practical test in these subjects and also English as compulsory subject.

#### OR

• The first year of the three years degree course of a University recognized by University Grants Commission (UGC) with Physics, Chemistry and Biology/ Biotechnology including practical tests in these subjects, provided the examination is a University Examination and further that he/she has passed the earlier qualifying examination with Physics, Chemistry, Biology/ Biotechnology and English.

#### OR

• B.Sc. Examination of an Indian University recognized by University Grants Commission (UGC), provided that he/she has passed B.Sc. Examination with not less than two of the subjects Physics, Chemistry, Biology (Botany, Zoology)/Bio-technology and further that he/ she has passed the earlier qualifying examination with Physics, Chemistry, Biology and English

- Any other examination which in scope and standard is found to be equivalent to the Intermediate Science Examination of an Indian University/ Board, taking Physics, Chemistry and Biology/Bio-technology including practical tests in each of these subjects and English. For such qualification, the candidates are required to obtain equivalence certificate from AIU (Association of Indian Universities, New Delhi).
- Candidates Qualified (10+2) under a foreign system in India, are required to obtain equivalence certificate from AIU (Association of Indian Universities, New Delhi).

#### **UNIVERSITY GRANTS COMMISSION, NEW DELHI** REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, 2009

NO.F 1-16/2007 (CPP-II)

#### Dated : 17th June, 2009

#### **PREAMBLE**

In view of the directions of the Hon'ble Supreme Court in the matter of "University of Kerala v/s. Council, Principals, Colleges and others" in SLP no. 24295 of 2006 dated 28.05.2007 and that dated 8.05.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government and the University Grants Commission to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the University Grants Commission, in consultation with the Councils, brings forth this Regulation. In exercise of the powers conferred by Clause (g) of sub-section (1) of Section 26 of the University Grants Commission Act, 1956, the University Grants Commission hereby makes the following regulations, namely;

#### 1. Title, commencement and applicability

- 1.1 These regulations shall be called the "UGC regulations on curbing the Menace of Ragging in Higher Educational Institutions, 2009."
- 1.2 They shall come into force from the date of their publication in the Official Gazette.
- 1.3 They shall apply to all the institutions coming within the definition of an University Under subsection (*f*) of section (2) of the University Grants Commission Act, 1956, and to all institutions deemed to be a university under Section 3 of the University Grants Commission Act, 1956, to all other higher educational institutions, or elements of such universities or institutions, including its departments, constituent units and all the premises whether being academic, residential, playgrounds, canteen, or other such premises of such universities, deemed universities and higher educational institutions, whether located inside campus or outside, and to all means of transportation of students, whether public or private, accessed by students for the pursuit of studies in such universities, deemed universities and higher educational institutions.

#### 2. Objectives

To prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student; and thereby, to eliminate ragging in all its forms from universities, deemed universities and other higher educational institutions in the country by prohibiting it under these Regulations, preventing its occurrence and punishing those who indulge in ragging as provided for in these Regulations and the appropriate law in force.

#### 3. What constitutes Ragging

Ragging constitutes one or more of any of the following acts :

- A. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- B. indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- C. asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- D. any act by a senior student that prevents, disrupts or disturbs the regular, academic activity of any other student or a fresher;
- E. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- F. any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- G. any act of physical abuse including all variants of it : sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- H. any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- I. any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

#### 4. Definitions

- 1. In these regulations unless the context otherwise requires
  - a) "Act" means, the University Grants Commission Act, 1956 (3 of 1956);
  - b) "Academic year" means the period from the commencement of admission of students in any course of study in the institution up to the completion of academic requirements for that particular year.
  - c) "Anti-Ragging Helpline" means the Helpline established under clause (a) of Regulation 8.1 of these Regulations.
  - d) "Commission" means the University Grants Commission;
  - e) "Council" means a body so constituted by an Act of Parliament or an Act of any State Legislature for setting, or co-ordinating or maintaining students in the relevant areas of higher education, such as the All India Council for Technical Education (AICTE), the Bar Council of India (BCI), the Dental Council of India (DCI), the Distance Education Council (DEC), the Indian Council of Agricultural Research (ICAR), the Indian Nursing Council (INC), the Medical Council of India (MCI), the National Council of Teacher Education (NCTE), the Pharmacy Council of India (PCI),etc. and the State Higher Education Councils.
  - f) "District Level Anti-Ragging Committee" means the Committee, headed by the District Magistrate, constituted by the State Government, for the control and elimination of ragging in institutions within the jurisdiction of the district.
  - g) "Head of the institution" means the Vice-Chancellor in case of a university or a deemed to be university, the Principal or the Director or such other designation as the executive head of the institution or the college is referred.
  - h) "Fresher" means a student who has been admitted to an institution and who is undergoing his/her first year of study in such institution.
  - i) "Institution" means a higher educational institution including, but not limited to an university, a deemed to be university, a college, an institute, an institution of national importance set up by an Act of Parliament or a constituent unit of such institution, imparting higher education beyond 12 years of schooling leading to, but not necessarily culminating in, a degree (graduate, postgraduate and/or higher level) and/or to a university diploma.
  - j) "NAAC" means the National Assessment and Accreditation Council established by the Commission under section 12(ccc) of the Act,

- k) "State Level Monitoring Cell" means the body constituted by the State Government for the control and elimination of ragging in institutions within the jurisdiction of the State, established under State Law or on the advice of the Central Government, as the case may be.
- 2) Words and expressions used and not defined herein but defined in the Act or in the General Clauses Act, 1897, shall have the meanings respectively assigned to them in the Act or in the General Clauses Act, 1897, as the case may be.

#### 5. Measures for prohibition of ragging at the institution level

- a) No institution or any part of it thereof, including, but not limited to, the departments, constituent units, colleges, centres of studies and all its premises, whether academic, residential, playgrounds, or canteen, whether located within the campus or outside, and in all means of transportation of students, whether public or private, accessed by students for the pursuit of studies in such institutions, shall permit or condone any reported incident of ragging in any form; and all institutions shall take all necessary and required measures, including but not limited to the provisions of these Regulations, to achieve the objective of eliminating ragging, within the institution or outside,
- b) All institutions shall take action in accordance with these Regulations against those found guilty of ragging and/or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.

#### 6. Measures for prevention of ragging at the institution level

- 6.1 An institution shall take the following steps in regard to admission or registration of students; namely,
  - a) Every public declaration of intent by any institution, in any electronic, audio-visual or print or any other media, for admission of students to any course of study shall expressly provide that ragging is totally prohibited in the institution, and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with these Regulations as well as under the provisions of any penal law for the time being in force.
  - b) The brochure of admission / instruction booklet or the prospectus, whether in print or electronic format, shall prominently print these Regulations in full. Provided that the institution shall also draw attention to any law concerning ragging and its consequences, as may be applicable to the institution publishing such brochure of admission / instruction booklet or the prospectus. Provided further that the telephone numbers of the Anti-Ragging Helpline and all the important functionaries in the institution including but not limited to the Head of the institution.

important functionaries in the institution, including but not limited to the Head of the institution, faculty members, members of the Anti-Ragging Committees and Anti-Ragging Squads, District and Sub – Divisional authorities, Wardens of hostels, and other functionaries or authorities where relevant, shall be published in the brochure of admission/ instruction booklet or the prospectus.

- c) Where an Institution is affiliated to a University and publishes a brochure of admission/ instruction booklet or a prospectus, the affiliating university shall ensure that the affiliated institution shall comply with the provisions of clause (a) and clause (b) of Regulation 6.1 of these Regulations.
- d) The application form for admission, enrolment or registration shall contain an affidavit, mandatorily in English and in Hindi and/or in one of the regional languages known to the applicant, as provided in the English language in Annexure I to these Regulations, to be filled up and signed by the applicant to the effect that he/she has read and understood the provisions of these Regulations as well as the provisions of any other law for the time being in force, and is aware of the prohibition of ragging and the punishments prescribed, both under penal laws as well as under these Regulations and also affirm to the effect that he/she has not been expelled and/or debarred by any institution and further aver that he/ she would not indulge, actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/ or abetting ragging, is liable to be proceeded against under these Regulations or under any penal law or any other law for the time being in force and such action would include but is not limited to debarment or expulsion of such student.
- e) The application form for admission, enrolment or registration shall contain an affidavit, mandatorily in English and in Hindi and/or in one of the regional languages known to the parents/guardians of the applicant, as provided in the English language in Annexure II to these Regulations, to be filled up

and signed by the parents/guardians of the applicant to the effect that he/she has read and understood the provisions of these Regulations as well as the provisions of any other law for the time being in force, and is aware of the prohibition of ragging and the punishments prescribed, both under penal laws as well as under these Regulations and also affirm to the effect that his/her ward has not been expelled; and/or debarred by any institution and further aver that his/her ward would not indulge, actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/ or abetting ragging, his/her ward is liable to be proceeded against under these Regulations or under any penal law or any other law for the time being in force and such action would include but is not limited to debarment or expulsion of his/ her ward.

- f) The application for admission shall be accompanied by a document in the form of, or annexed to, the School Leaving Certificate/Transfer Certificate/Migration Certificate/ Character Certificate reporting on the inter-personal/social behavioral pattern of the applicant, to be issued by the school or institution last attended by the applicant, so that the institution can thereafter keep watch on the applicant, if admitted, whose behavior has been commented in such document.
- g) A student seeking admission to a hostel forming part of the institution, or seeking to reside in any temporary premises not forming part of the institution, including a private commercially managed lodge or hostel, shall have to submit additional affidavits countersigned by his/her parents/guardians in the form prescribed in Annexure I and Annexure II to these Regulations respectively along with his/her application.
- h) Before the commencement of the academic session in any institution, the Head of the Institution shall convene and address a meeting of various functionaries/agencies, such as Hostel Wardens, representatives of students, parents/ guardians, faculty, district administration including the police, to discuss the measures to be taken to prevent ragging in the institution and steps to be taken to identify those indulging in or abetting ragging and punish them.
- i) The institution shall, to make the community at large and the students in particular aware of the dehumanizing effect of ragging, and the approach of the institution towards those indulging in ragging, prominently display posters depicting the provisions of penal law applicable to incidents of ragging, and the provisions of these Regulations and also any other law for the time being in force, and the punishments thereof, shall be prominently displayed on Notice Boards of all departments, hostels and other buildings as well as at places, where students normally gather and at places, known to be vulnerable to occurrences of ragging incidents.
- j) The institutions shall request the media to give adequate publicity to the law prohibiting ragging and the negative aspects of ragging and the institution's resolve to ban ragging and punish those found guilty without fear or favour.
- k) The institution shall identify, properly illuminate and keep a close watch on all locations known to be vulnerable to occurrences of ragging incidents.
- I) The institution shall tighten security in its premises, especially at vulnerable places and intense policing by Anti-Ragging Squad, referred to in these Regulations and volunteers, if any, shall be resorted to at such points at odd hours during the first few months of the academic session.
- m) The institution shall utilize the vacation period before the start of the new academic year to launch a publicity campaign against ragging through posters, leaflets and such other means, as may be desirable or required, to promote the objectives of these regulations.
- n) The faculties/departments/units of the institution shall have induction arrangements, including those which anticipate, identify and plan to meet any special needs of any specific section of students, in place well in advance of the beginning of the academic year with an aim to promote the objectives of this Regulation.
- o) Every institution shall engage or seek the assistance of professional counsellors before the commencement of the academic session, to be available when required by the institution, for the purposes of offering counselling to fresher's and to other students after the commencement of the academic year.
- p) The head of the institution shall provide information to the local police and local authorities, the details of every privately commercially managed hostels or lodges used for residential purposes by

students enrolled in the institution and the head of the institution shall also ensure that the Anti-Ragging Squad shall ensure vigil in such locations to prevent the occurrence of ragging therein.

- 6.2 An institution shall, on admission or enrolment or registration of students, take the following steps, namely;
  - a) Every fresh student admitted to the institution shall be given a printed leaflet detailing to whom he/she has to turn to for help and guidance for various purposes including addresses and telephone numbers, so as to enable the student to contact the concerned person at any time, if and when required, of the Anti-Ragging Helpline referred to in these Regulations, Wardens, Head of the institution, all members of the anti-ragging squads and committees, relevant district and police authorities;
  - b) The institution, through the leaflet specified in clause (a) of Regulation 6.2 of these Regulations shall explain to the fresher's, the arrangements made for their induction and orientation which promote efficient and effective means of integrating them fully as students with those already admitted to the institution in earlier years.
  - c) The leaflet specified in clause (a) of Regulation 6.2 of these Regulations shall inform the fresher's about their rights as bona fide students of the institution and clearly instructing them that they should desist from doing anything, with or against their will, even if ordered to by the senior students, and that any attempt of ragging shall be promptly reported to the Anti-ragging Squad or to the Warden or to the Head of the institution, as the case may be.
  - d) The leaflet specified in clause (a) of Regulation 6.2 of these Regulations shall contain a calendar of events and activities laid down by the institution to facilitate and complement familiarization of fresher's with the academic environment of the institution.
  - e) The institution shall, on the arrival of senior students after the first week or after the second week, as the case may be, schedule orientation programmes as follows, namely; (i) joint sensitization programme and counselling of both fresher's and senior students by a professional counsellor, referred to in clause (o) of Regulation 6.1 of these Regulations;
  - (ii) joint orientation programme of fresher's and seniors to be addressed by the Head of the institution and the anti -ragging committee; (iii) organization on a large scale of cultural, sports and other activities to provide a platform for the fresher's and seniors to interact in the presence of faculty members; (iv) in the hostel, the warden should address all students; and may request two junior colleagues from the college faculty to assist the warden by becoming resident tutors for a temporary duration. (v) as far as possible faculty members should dine with the hostel residents in their respective hostels to instill a feeling of confidence among the fresher's.
  - f) The institution shall set up appropriate committees, including the course-in-charge, student advisor, Wardens and some senior students as its members, to actively monitor, promote and regulate healthy interaction between the fresher's, junior students and senior students.
  - *g)* Fresher's or any other student(s), whether being victims, or witnesses, in any incident of ragging, shall be encouraged to report such occurrence, and the identity of such informants shall be protected and shall not be subject to any adverse consequence only for the reason for having reported such incidents.
  - h) Each batch of fresher's, on arrival at the institution, shall be divided into small groups and each such group shall be assigned to a member of the faculty, who shall interact individually with each member of the group every day for ascertaining the problems or difficulties, if any, faced by the fresher in the institution and shall extend necessary help to the fresher in overcoming the same.
  - i) It shall be the responsibility of the member of the faculty assigned to the group of fresher's, to coordinate with the Wardens of the hostels and to make surprise visits to the rooms in such hostels, where a member or members of the group are lodged; and such member of faculty shall maintain a diary of his/her interaction with the fresher's under his/her charge.
  - j) Fresher's shall be lodged, as far as may be, in a separate hostel block, and where such facilities are not available, the institution shall, ensure that access of seniors to accommodation allotted to fresher's is strictly monitored by wardens, security guards and other staff of the institution.
  - k) A round the clock vigil against ragging in the hostel premises, in order to prevent ragging in the hostels after the classes are over, shall be ensured by the institution.

- I) It shall be the responsibility of the parents/guardians of fresher's to promptly bring any instance of ragging to the notice of the Head of the Institution.
- m) Every student studying in the institution and his / her parents / guardians shall provide the specific affidavits required under clauses (d), (e) and (g) of Regulation 6.1 of these Regulations at the time of admission or registration, as the case may be, during each academic year.
- n) Every institution shall obtain the affidavit from every student as referred to above in clause (m) of Regulation 6.2 and maintain a proper record of the same and to ensure its safe upkeep thereof, including maintaining the copies of the affidavit in an electronic form, to be accessed easily when required either by the Commission; or any of the Councils or by the institution or by the affiliating University or by any other person or organization authorized to do so.
- o) Every student at the time of his/her registration shall inform the institution about his/ her place of residence while pursuing the course of study, and in case the student has not decided his/her place of residence or intends to change the same, the details of his place of residence shall be provided immediately on deciding the same; and specifically in regard to a private commercially managed lodge or hostel where he/she has taken up residence.
- p) The Head of the institution shall, on the basis of the information provided by the student under clause (o) of Regulation 6.2, apportion sectors to be assigned to members of the faculty, so that such member of faculty can maintain vigil and report any incident of ragging outside the campus or en route while commuting to the institution using any means of transportation of students, whether public or private.
- q) The Head of institution shall, at the end of each academic year, send a letter to the parents/guardians of the students who are completing their first year in the institution, informing them about these Regulations and any law for the time being in force prohibiting ragging and the punishments thereof as well as punishments prescribed under the penal laws, and appealing to them to impress upon their wards to desist from indulging in ragging on their return to the institution at the beginning of the academic session next.
- 6.3 Every institution shall constitute the following bodies; namely,
  - a) Every institution shall constitute a Committee to be known as the Anti-Ragging Committee to be nominated and headed by the Head of the institution, and consisting of representatives of civil and police administration, local media, Non-Government Organizations involved in youth activities, representatives of faculty members, representatives of parents, representatives of students belonging to the fresher's category as well as senior students, non-teaching staff; and shall have a diverse mix of membership in terms of levels as well as gender.
  - b) It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
  - c) Every institution shall also constitute a smaller body to be known as the Anti-Ragging Squad to be nominated by the Head of the Institution with such representation as may be considered necessary for maintaining vigil, oversight and patrolling function and shall remain mobile, alert and active at all times. Provided that the Anti-Ragging Squad shall have representation of various members of the campus community and shall have no outside representation.
  - d) It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise raids on hostels, and other places vulnerable to incidents of, and having the potential of, ragging and shall be empowered to inspect such places.
  - e) It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incident of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendation shall be submitted to the Anti-Ragging Committee for action under clause (a) of Regulation 9.1. Provided that the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students

accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required.

- f) Every institution shall, at the end of each academic year, in order to promote the objectives of these regulations, constitute a Mentoring Cell consisting of students volunteering to be Mentors for fresher's, in the succeeding academic year; and there shall be as many levels or tiers of Mentors as the number of batches in the institution, at the rate of one Mentor for six fresher's and one Mentor of a higher level for six Mentors of the lower level.
- g) Every University shall constitute a body to be known as Monitoring Cell on Ragging, which shall coordinate with the affiliated colleges and institutions under the domain of the University to achieve the objectives of these Regulations; and the Monitoring Cell shall call for reports from the Heads of institutions in regard to the activities of the Anti-Ragging Committees, Anti Ragging Squads, and the Mentoring Cells at the institutions, and it shall also keep itself abreast of the decisions of the District level Anti-Ragging Committee headed by the District Magistrate.
- h) The Monitoring Cell shall also review the efforts made by institutions to publicize ant ragging measures, soliciting of affidavits from parents/guardians and from students, each academic year, to abstain from ragging activities or willingness to be penalized for violations; and shall function as the prime mover for initiating action on the part of the appropriate authorities of the university for amending the Statutes or Ordinances or Byelaws to facilitate the implementation of anti-ragging measures at the level of the institution.
- 6.4 Every institution shall take the following other measures, namely;
  - a) Each hostel or a place where groups of students reside, forming part of the institution, shall have a full-time Warden, to be appointed by the institution as per the eligibility criteria laid down for the post reflecting both the command and control aspects of maintaining discipline and preventing incidents of ragging within the hostel, as well as the softer skills of counselling and communicating with the youth outside the class-room situation; and who shall reside within the hostel, or at the very least, in the close vicinity thereof.
  - b) The Warden shall be accessible at all hours and be available on telephone and other modes of communication, and for the purpose the Warden shall be provided with a mobile phone by the institution, the number of which shall be publicized among all students residing in the hostel.
  - c) The institution shall review and suitably enhance the powers of Wardens; and the security personnel posted in hostels shall be under the direct control of the Warden and their performance shall be assessed by them.
  - d) The professional counsellors referred to under clause (o) of Regulation 6.1 of these Regulations shall, at the time of admission, counsel fresher's and/or any other student(s) desiring counselling, in order to prepare them for the life ahead, particularly in regard to the life in hostels and to the extent possible, also involve parents and teachers in the counseling sessions.
  - e) The institution shall undertake measures for extensive publicity against ragging by means of audiovisual aids, counselling sessions, workshops, painting and design competitions among students and such other measures, as it may deem fit.
  - f) In order to enable a student or any person to communicate with the Anti-Ragging Helpline, every institution shall permit unrestricted access to mobile phones and public phones in hostels and campuses, other than in class-rooms, seminar halls, library, and in such other places that the institution may deem it necessary to restrict the use of phones.
  - g) The faculty of the institution and its non-teaching staff, which includes but is not limited to the administrative staff, contract employees, security guards and employees of service providers providing services within the institution, shall be sensitized towards the ills of ragging, its prevention and the consequences thereof.
  - h) The institution shall obtain an undertaking from every employee of the institution including all teaching and non-teaching members of staff, contract labors employed in the premises either for running canteen or as watch and ward staff or for cleaning or maintenance of the buildings/lawns and employees of service providers providing services within the institution, that he/she would report promptly any case of ragging which comes to his/her notice.

- i) The institution shall make a provision in the service rules of its employees for issuing certificates of appreciation to such members of the staff who report incidents of ragging, which will form part of their service record.
- j) The institution shall give necessary instructions to the employees of the canteens and messing, whether that of the institution or that of a service provider providing this service, or their employers, as the case may be, to keep a strict vigil in the area of their work and to report the incidents of ragging to the Head of the institution or members of the Anti- Ragging Squad or members of the Anti-Ragging Committee or the Wardens, as may be required.
- k) All Universities awarding a degree in education at any level, shall be required to ensure that institutions imparting instruction in such courses or conducting training programme for teachers include inputs relating to anti-ragging and the appreciation of the relevant human rights, as well as inputs on topics regarding sensitization against corporal punishments and checking of bullying amongst students, so that every teacher is equipped to handle at least the rudiments of the counselling approach.
- Discreet random surveys shall be conducted amongst the fresher's every fortnight during the first three months of the academic year to verify and cross-check whether the institution is indeed free of ragging or not and for the purpose the institution may design its own methodology of conducting such surveys.
- m) The institution shall cause to have an entry, apart from those relating to general conduct and behavior, made in the Migration/Transfer Certificate issued to the student while leaving the institution, as to whether the student has been punished for committing or abetting an act of ragging, as also whether the student has displayed persistent violent or aggressive behavior or any inclination to harm others, during his course of study in the institution.
- n) Notwithstanding anything contained in these Regulations with regard to obligations and responsibilities pertaining to the authorities or members of bodies prescribed above, it shall be the general collective responsibility of all levels and sections of authorities or functionaries including members of the faculty and employees *of* the institution, whether regular or temporary, and employees of service providers providing service within the institution, to prevent or to act promptly against the occurrence of ragging or any incident of ragging which comes to their notice.
- o) The Heads of institutions affiliated to a University or a constituent of the university, as the case may be, shall, during the first three months of an academic year, submit a weekly report on the status of compliance with Anti Ragging measures under these Regulations, and a monthly report on such status thereafter, to the Vice-Chancellor of the University to which the institution is affiliated to or recognized by.
- p) The Vice Chancellor of each University, shall submit fortnightly reports of the University, including those of the Monitoring Cell on Ragging in case of an affiliating university, to the State Level Monitoring Cell.

#### 7. Action to be taken by the Head of the institution

On receipt of the recommendation of the Anti-Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

- i. Abetment to ragging;
- ii. Criminal conspiracy to rag;
- iii. Unlawful assembly and rioting while ragging;
- iv. Public nuisance created during ragging;
- v. Violation of decency and morals through ragging;
- vi. Injury to body, causing hurt or grievous hurt;
- vii. Wrongful restraint;
- viii. Wrongful confinement;

- ix. Use of criminal force;
- x. Assault as well as sexual offences or unnatural offences;
- xi. Extortion;
- xii. Criminal trespass;
- xiii. Offences against property;
- xiv. Criminal intimidation;
- xv. Attempts to commit any or all of the above mentioned offences against the victim(s);
- xvi. Threat to commit any or all of the above mentioned offences against the victim(s);
- xvii. Physical or psychological humiliation;
- xviii. All other offences following from the definition of "Ragging". Provided that the Head of the institution shall forthwith report the occurrence of the incident of ragging to the District Level Anti-Ragging Committee and the Nodal officer of the affiliating University, if the institution is an affiliated institution. Provided further that the institution shall also continue with its own enquiry initiated under clause 9 of these Regulations and other measures without waiting for action on the part of the police/local authorities and such remedial action shall be initiated and completed immediately and in no case later than a period of seven days of the reported occurrence of the incident of ragging.

#### 8. Duties and Responsibilities of the Commission and the Councils

- 8.1 The Commission shall, with regard to providing facilitating communication of information regarding incidents of ragging in any institution, take the following steps, namely;
  - a) The Commission shall establish, fund and operate, a toll-free Anti-Ragging Helpline, operational round the clock, which could be accessed by students in distress owing to ragging related incidents.
  - b) Any distress message received at the Anti-Ragging Helpline shall be simultaneously relayed to the Head of the Institution, the Warden of the Hostels, the Nodal Officer of the affiliating University, if the incident reported has taken place in an institution affiliated to a University, the concerned District authorities and if so required, the District Magistrate, and the Superintendent of Police, and shall also be web enabled so as to be in the public domain simultaneously for the media and citizens to access it.
  - c) The Head of the institution shall be obliged to act immediately in response to the information received from the Anti-Ragging Helpline as at sub-clause (b) of this clause.
  - d) The telephone numbers of the Anti-Ragging Helpline and all the important functionaries in every institution, Heads of institutions, faculty members, members of the anti-ragging committees and anti-ragging squads, district and sub-divisional authorities and state authorities, Wardens of hostels, and other functionaries or authorities, where relevant, shall be widely disseminated for access or to seek help in emergencies.
  - e) The Commission shall maintain an appropriate data base to be created out of affidavits, affirmed by each student and his/her parents/guardians and stored electronically by the institution, either on its or through an agency to be designated by it; and such database shall also function as a record of ragging complaints received, and the status of the action taken thereon.
  - f) The Commission shall make available the database to a non-governmental agency to be nominated by the Central Government, to build confidence in the public and also to provide information of noncompliance with these Regulations to the Councils and to such bodies as may be authorized by the Commission or by the Central Government.

#### 8.2 The Commission shall take the following regulatory steps, namely;

- a) The Commission shall make it mandatory for the institutions to incorporate in their prospectus, the directions of the Central Government or the State Level Monitoring Committee with regard to prohibition and consequences of ragging, and that noncompliance with these Regulations and directions so provided, shall be considered as lowering of academic standard by the institution, therefore making it liable for appropriate action.
- b) The Commission shall verify that the institutions strictly comply with the requirement of getting the affidavits from the students and their parents/guardians as envisaged under these Regulations.

- c) The Commission shall include a specific condition in the Utilization Certificate, in respect of any financial assistance or grants-in-aid to any institution under any of the general or special schemes of the Commission that the institution has complied with the anti-ragging measures.
- d) Any incident of ragging in an institution shall adversely affect its accreditation, ranking or grading by NAAC or by any other authorized accreditation agencies while assessing the institution for accreditation, ranking or grading purposes.
- e) The Commission may accord priority in financial grants-in-aid to those institutions, otherwise eligible to receive grants under section 12B of the Act, which report a blemish less record in terms of there being no reported incident of ragging.
- f) The Commission shall constitute an Inter-Council Committee, consisting of representatives of the various Councils, the Non-Governmental agency responsible for monitoring the database maintained by the Commission under clause (g) of Regulation 8.1 and such other bodies in higher education, to coordinate and monitor the anti-ragging measures in institutions across the country and to make recommendations from time to time; and shall meet at least once in six months each year.
- g) The Commission shall institute an Anti-Ragging Cell within the Commission as an institutional mechanism to provide secretarial support for collection of information and monitoring, and to coordinate with the State Level Monitoring Cell and University level Committees for effective implementation of anti-ragging measures, and the Cell shall also coordinate with the Non-Governmental agency responsible for monitoring the database maintained by the Commission appointed under clause (g) of Regulation 8.1.

#### 9. Administrative action in the event of ragging

- 9.1 The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under:
  - a) The Anti-Ragging Committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
  - b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:
    - i. Suspension from attending classes and academic privileges.
    - ii. Withholding / withdrawing scholarship / fellowship and other benefits.
    - iii. Debarring from appearing in any test/ examination or other evaluation process.
    - iv. Withholding results.
    - v. Debarring from representing the institution in any regional, national or international meet, ornament, youth festival, etc.
    - vi. Suspension / expulsion from the hostel.
    - vii. Cancellation of admission.
    - viii. Rustication from the institution for period ranging from one to four semesters.
    - ix. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of ragging are not
    - x. Identified, the institution shall resort to collective punishment.
    - xi. An appeal against the order of punishment by the Anti Ragging Committee shall lie,
    - xii. in case of an order of an institution, affiliated to or constituent part, of a University, to the Vice-Chancellor of the University;
    - xiii. In case of an order of a University, to its Chancellor.
    - xiv. In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be.
- 9.2 Where an institution, being constituent of, affiliated to or recognized by a University, fails to comply with any of the provisions of these Regulations or fails to curb ragging effectively, such University may take any one or more of the following actions, namely;
  - i. Withdrawal of affiliation/recognition or other privileges conferred.

- ii. Prohibiting such institution from presenting any student or students then undergoing any programme of study therein for the award of any degree / diploma of the University. Provided that where an institution is prohibited from presenting its student or students, the Commission shall make suitable arrangements for the other students so as to ensure that such students are able to pursue their academic studies.
- iii. Withholding grants allocated to it by the university, if any
- iv. Withholding any grants channelized through the university to the institution.
- v. Any other appropriate penalty within the powers of the university.
- 9.3 Where in the opinion of the appointing authority, a lapse is attributable to any member of the faculty or staff of the institution, in the matter of reporting or taking prompt action to prevent an incident of ragging or who display an apathetic or insensitive attitude towards complaints of ragging, or who fail to take timely steps, whether required under these Regulations or otherwise, to prevent an incident or incidents of ragging, then such authority shall initiate departmental disciplinary action, in accordance with the prescribed procedure of the institution, against such member of the faulty or staff. Provided that where such lapse is attributable to the Head of the institution, the authority designated to appoint such Head shall take such departmental disciplinary action; and such action shall be without prejudice to any action that may be taken under the penal laws for abetment of ragging for failure to take timely steps in the prevention of ragging or punishing any student found guilty of ragging.
- 9.4 The Commission shall, in respect of any institution that fails to take adequate steps to prevent ragging or fails to act in accordance with these Regulations or fails to punish perpetrators or incidents of ragging suitably, take one of more of the following measures, namely;
  - i. Withdrawal of declaration of fitness to receive grants under section 12B of the Act.
  - ii. Withholding any grant allocated.
  - iii. Declaring the institution ineligible for consideration for any assistance under any of the general or special assistance programmes of the Commission. iv. Informing the general public, including potential candidates for admission, through a notice displayed prominently in the newspapers or other suitable media and posted on the website of the Commission, declaring that the institution does not possess the minimum academic standards.
  - v. Taking such other action within its powers as it may deem fit and impose such other penalties as may be provided in the Act for such duration of time as the institution complies with the provisions of these Regulations. Provided that the action taken under this clause by the Commission against any institution shall be shared with all Councils.

#### Subject: Revised procedure for students to file online Anti Ragging Affidavit.

Dear Madam/Sir,

As you are aware, in pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and in compliance of the 2<sup>nd</sup> Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely, www.antiragging.in and www.amanmovement.org.

As part of UGC's initiative towards reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

#### The revised procedure is as follows:

**Step 1:** A student will submit his/her details on the same web sites (**www.antiragging.in** and **<u>www.amanmovement.org</u>**) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

**Step 2:** The student will receive an E MAIL with his/her registration number and a web link. The student will forward the link to the E mail of the Nodal officer in his/her university/college. (Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).

**Step 3:** The Nodal Officer in the university/college can click on the link of any forwarded e mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.
