# **By-Laws for Grievances Committee**

- 1. As per Article (15) of MOA of Pravara Institute of Medical Sciences, there shall be a Grievances Committee in the University to deal with the grievances of teachers and other employees of the Deemed University and its constituent colleges / institutes / centers / schools and to hear and settle grievances of these employees. The committee shall report to the Board of Management for further action, if any.
- 2. It shall be lawful for the Grievances Committee to entertain and consider grievances or complaints and report to the Board of Management to take such action as it deems fit and the decision of the Board of Management on such report shall be final.
- 3. The Grievances Committee shall consists of the following members,
  - 1) Pro-Vice-Chancellor Chairman
  - 2) Two representatives nominated by BOM from the members of BOM
  - 3) One Head of the Constituent institutions / colleges/ nominated by BOM
  - 4) One Senior teacher nominated by the Vice-Chancellor
  - 5) One representative of Non-teaching staff nominated by Vice-Chancellor
  - 6) The Registrar as a secretary
  - Registrar shall not have a right to vote.
- 4. The employee of the Deemed University and constituent institutes / colleges / centers/ schools shall have to submit his / her complaint in a prescribed form along with necessary documents in support of his / her complaint. The employee shall have to apply individually and represent his / her case before Grievances Committee. No proxy will be allowed to represent his / her case.

5. The committee may give its recommendations as far as possible within a period of

six months.

6. The employee shall not be allowed to file a case in any court when the matter is

pending before the Grievances Committee.

7. The Board of Management shall take final decision after receiving the report from

the Grievances Committee. The decision of Board of Management shall be

binding on both the parties.
