- Fees will be constant for 2025-26 batch for three years and thereafter for M.B.B.S. 15%, B.D.S. 10% and BAMS 10% fees will be increased for the said batch.
- Eligibility fees will be charged 5% on Tuition fees.
- Based on the demand for Post Graduate Courses, we may reduce the fees accordingly.

The Fee Structure in Medical, Dental and Ayurved Under Graduate and Post Graduate level Academic Programme fixed for the admission year 2025-26 will be valid for a period of next three years for the said batches. Then onwards, the fees for M.B.B.S. shall be increased by 15% (Fifteen Percent), B. D. S. Course shall be increased by 10% (Ten Percent) and the fees for B.A.M.S. Course shall be increased by 10% (Ten Percent) of the existing fees for the remaining period of the Programme from the Academic Year 2028-29 (i.e. for the First year MBBS, BDS and BAMS batch of 2025-26).
