## Notification No- 27 /2022

### Regulations Governing Fellowship of Programmes at Constituents Colleges of PIMS -DU

#### 1. Short Title of the Regulation:-

- i. These Regulation, are titled as " Regulations Governing Fellowship Programm at the Constituent Colleges of Pravara Institute of Medical Sciences .It shall come in to effect from the date of Notification of the same by the University and amended from time to time.
- ii. The PIMS-DU through its constituent Colleges, offer Fellowship Program, meant to enhance the applied knowledge, skills, competencies befitting to a specialized subject.

#### 2. Type of Fellowship Programme:

- A. Post- doctoral Fellowship Programme
- B. Fellowship Programme

#### 3. Eligibility:

##### A. For Post-Doctoral Fellowship Programme

- i. Faculty of Medicine: MD/MS/DNB/PG Diploma in Medicine, M. Sc. Medical (After completion of Ph. D.)/MBBS.
- ii. Faculty of Dentistry: MDS/BDS
- iii. Faculty of Allied Health Sciences (Physiotherapy):MPT/ BPT



**B. For Fellowship Programme**

- i. Faculty of Nursing: Successful completion of compulsory internship as per statutory council norms for the students of B. Sc. Nursing, P. B. B Sc. Nursing etc.
- ii. M. Sc (Nursing)
- iii. Faculty of Allied Health Sciences (Biotechnology): B. Sc. Medical Biotechnology, M. Sc. Medical Biotechnology.
- iv. Faculty of Allied Health Sciences (Social Medicine): MPH/MSW/MD/MS/MDS/MPT, M.Sc. (BT) for Fellowship in Public Health/ Medical Social Work under the Faculty of Allied Health Sciences at CSM.

C. Minimum of 50% of marks at the said PG Examination.

D. Registration for Medical /Dental/Nursing/Physiotherapy Practice from respective Statutory Council for pursuing Fellowship program at Constituent Units of PIMS (DU) Loni.

4. **Intake:** - It shall be fixed by PIMS (DU) & Notified from time to time. The mode of selection is merit on interview cum counseling.
5. **Fee:-** It shall be Fixed by PIMS (DU) & Notified
6. **Admission Process:-**
  - i. Notification shall be issued by the University as per the recommendation of AC/HoI/HoD and authorities of PIMS.
  - ii. The HoI shall process the applications as per eligibility in accordance with the Conditions/Rules and admit the applicant after verifying all the necessary documents & records by accepting payment of fees prescribed & other aspects as per normal procedure.
7. **Duration of the Fellowship programme-** One/One and half/Two years as may be the approved by Academic Council.
8. **Attendance:** - Minimum of 80% and above in an academic term of 6 months. The leave policy of PG student is applicable.
9. **Teaching** -It shall include clinical postings/field postings/OPD-IPD-Casualty, ICU Posting/Posting to Allied support & Diagnostic Departments/Wards Round/UG-PG teaching schedule/CM/CPC/and so on.The weekly teaching schedule also includes Journal club, Case presentations, Seminars,Group Discussions, PBL,CBL,CAL, SDL, Faculty lecture, Guest lecture, Medical Campus inter departmental teaching activities, H/V integrated teaching, panel discussions and so on.



#### 10. Mandatory Fulfillment:

- i. Mandatory Participation in the UG PG Teaching (6 per Year), Presentation of Assignment (6 per Year). Research Methodology workshop (One).
- ii. Participation & presentation with minimum one Research article in Seminars/Conferences /Workshops Etc.
- iii. One research paper publication in Index/ Scopus/ UGC Care list. (Acceptance for publications or Published).

#### 11. Assessment and Evaluation (Similar to PG Student of the Dept.)

- i. **Internal Assessment-** At the Dept- Level

\* Once in 3 months/ Quarterly

\* Internal Evaluation be done by the PG Teacher in charge of fellow nominated by HOD.

\* Internal Assessment Performance Appraisal shall be done as per the Annexure enclosed .(Annexure I)

- ii. **Term End Examination:** Term end examination will be arranged and conducted by concerned department and the same would declare the result after seeking approval of Registrar through Head of Institute. The concern Head of Department should prepare the Certificate and submit it to the Concern Head of Institute and Registrar for Signature

**There shall be two theory papers-**

**Paper-I** on the subject of Fellowship

**Paper-II** Recent advances in the subject of Fellowship.

**Note:** 1. Title and detailed syllabus to Paper I & II to be specified and drafted by BOS/HOD/Deans and to be approved by BOS / AC and authorities of the University.

2. The curricular transaction and delivery [syllabus]and training may be specified by the BOS / and approved by Academic Council and authorities of PIMS-DU

**Scheme of Examination-** Theory (200 Marks)+ Practical (200 Marks)  
Total = 400Marks.

**Theory Examination-** 200 Marks.

Each of 100 Marks and 3 Hours Duration

-2 long Questions of 20 Marks each =40 Marks.

- 6 short Questions of 10 Marks each =60 Marks.



1) Paper -I: Title ----- Based on the Specialty of the Fellowship.

2) Paper -II :Recent advances in the subject of fellowship.

**Practical /Clinical Examination -200 marks.**

i) One long Case/ long experiment -50 Marks

ii) Three Short Cases (3x30)-90 Marks

Viva Voce/ Oral/OSPE/Spottesetc -60 Marks.

**Minimum Passing Standard:-**

\* Minimum 50% in Theory papers (Each paper minimum is 40%)

\* Minimum 50% in Practical /Clinical & Viva Voce

\* Overall is 50% of Theory & Practical/Clinical.

\* Award of class:- \*Min 50% to 59.5% - Second class

60 to 74.5% -I Class.

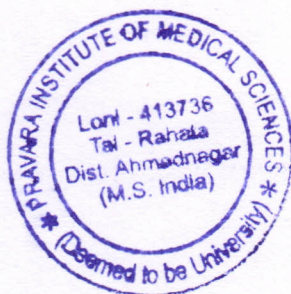
Above 75% - I Class with Distinction

**Issue of Mark sheet:** As per the approved prescribed Proforma, duly signed by Head of Institute and counter signed by Head of Department be issued to students after announcement of result.

12. The BOS of the respective subject vis a vis the Department shall draft the Syllabi for Paper-I,II and Practicals (Skill and competency) and Curricular Transaction /Delivery befitting to the subject & specialty of fellowship & get it approved from Academic Council & get it Notified by PIMS (DU)
13. The HoD of the concerned subject & HoI shall be responsible for the maintenance of records of activities, attendance, CIA & other academic administrative aspects & report to PIMS (DU) from time to time.
14. The HoD- shall ensure Attendance, Teaching- Learning Process of fellow as per Regulations& get the Syllabi approved& conduct Continues Internal Assessment. The Proforma for CIA which is to be conducted quarterly is enclosed. All the documents shall be maintained by HoD/HoI.



15. Only those students eligible to appear for Examinations in term of attendance Teaching Learning process, CIA, log book etc shall be allowed to appear for examination. Students those who comply with norms with respect to attendance, teaching learning process, CIA etc. shall only be allowed to appear for examination. Only the recognized PG teachers with the specialization shall be eligible to become Examiner from the approved panel of Examiners. The *Head of Department* shall arrange for conducting the examination during the last month of the fellowship programme & announce the result with the due approval of PIMS(DU).
16. A student- shall clear the Examination only within three attempts or within 4 years of admission.
17. The Budget for running the program shall be availed from the budget of the department that is sanctioned and to be sanctioned from time to time by PIMS.
18. Saving Clause: - In case of difficulty, the decision of the authorities of PIMS (DU) shall be Final.
