**Admission to Under Graduate Courses MBBS & BDS for 2021-22**

**SECOND ROUND of Admission**

**( 27<sup>th</sup> February, 2022 to 05<sup>th</sup> March, 2022 )**

Candidates selected by Medical Counseling Committee of DGHS, New Delhi in **Round-II** of admission for Admission to MBBS/ BDS in **Rural Medical College, Loni (200370) & Rural Dental College, Loni (200369)** are required to bring following documents while reporting to college for admission. Eligibility for the admission will be on the basis of eligibility criteria laid down by statutory bodies.

You will have to remain physically present yourself for admission along with the required Original Certificates and Demand Draft for payment of full fees as mentioned below.

**DOCUMENTS :** You shall have to produce following Original Documents along with Three Self Attested sets of their photocopies.

1. Provisional Allotment Letter generated Online from DGHS Website ( www.mcc.nic.in )
2. NEET-UG 2021 Admit Card issued by National Testing Agency (NTA).
3. NEET-UG 2021 Result/ Rank letter issued by National Testing Agency (NTA).
4. Certificate of Birth / Age ( S.S.C. Passing Certificate / Valid Passport )
5. S.S.C. / Equivalent Statement of Marks and Passing Certificate.
6. H.S.C. / Equivalent Statement of Marks and Passing Certificate.
7. Photo identity proof ( AADHAR Card/PAN /Passport/Driving Licence )
8. Leaving / Transfer Certificate
9. Migration certificate
10. Gap Certificate ( If passed 10+2 before 2021)
11. Medical fitness certificate from a registered medical practitioner.
12. Caste Validity certificate (by candidates belonging to all Backward class)
13. AIU (Association of Indian Universities) Equivalence certificate (if studied under foreign system in India)
14. Nationality Certificate / Valid passport / Domicile Certificate
15. Disability Certificate ( If applicable )
16. Passport (In case of Foreign National/ Wards of person of Indian origin /Wards of NRI)
17. Six passport size colour photographs
18. For NRI/PIO/OCI candidates following documents are mandatory:
  - Documents claiming that the sponsorer is an NRI
    - a. Certificate from Consulate/ embassy that the sponsorer is NRI
    - b. Valid Passport
    - c. Valid Visa of the sponsorer
  - Valid address proof (foreign country address) of the sponsor
  - Affidavite of Relationship of NRI with the candidate. (As per Supreme Court Order)
  - All the essential documents (e.g. birth certificates, passport etc.) of the family members to establish the exact relationship between candidate and the sponsor.
  - Affidavit from the sponsorer that he/ she will sponsor the entire course fee of the candidate duly notarized.
  - NEET-UG Score Card of the candidate.

- **All the allotted candidates will receive a document verification form link by registered E-mail/ Mobile No. Please fill this form carefully & upload requisites original documents soft copies carefully & submit it online before reporting.**

**It is mandatory to submit original document at the time of admission. Candidates without original documents will not be entertained under any circumstances.**

Candidates who have deposited their original documents with any other Institute/College/ University and come for admission with a certificate stating that “their original certificate are deposited with the institute/ College/ University” will not be allowed to take admission. Kindly note that there will be no reservation for OBC/ SC/ ST/ PWD candidates in Deemed Universities.
